1. Who is the data controller?

- information relating to the use of the purchased machinery, their monitoring and where the MGCloud service or other monitoring services of the MG products has been activated, the data relating to the geographical position could be collected.

4. What are your rights?

You have the right to obtain information regarding the processing of your personal data, to obtain access and a copy thereof also through commonly used electronic means.

You have the right to obtain the updating, integration or rectification of your data.

You can request the portability of the data processed in light of the execution of a contract or on the basis of your consent.

If you are interested, you have the right to request the deletion of your data.

You have the right to request the restriction of the processing or to object, in whole or in part, to the processing of your personal data.

If you believe that one or more processes carried out by us may be a violation of the law, or believe that your rights have not been protected, you can send a complaint to the Supervisory Authority of the place where you usually reside, work or where the alleged violation has occurred.



5. To whom could your personal data be disclosed?

The data will be processed by personnel tasked therewith, suitably trained and operating under the authority and the responsibility of the Controller. Certain information may be disclosed to the following subjects:

- Dealers and/or importers who have agreements for the distribution and promotion of the MG products, as well as the task of carrying out the after-sales technical assistance guaranteed by the contract
- Public bodies (Tax offices and other bodies);
- Legal or consultancy firms to which the Data Controller has conferred a specific mandate;
- IT system support and maintenance companies or providers of IT archival systems;
- Other subjects or companies that carry out activities that are instrumental to the purposes mentioned above.

The data may also be disclosed to the group's other companies. When made outside of the European Union, such disclosure, performed in the legitimate interest of the group of companies to share data and information, unify tools and procedures used in the processing, is performed in full compliance with all safeguards envisaged by the regulatory framework on the protection of personal data and assuring adequate protection of the data subject through the execution of specific agreements (Standard Contractual Clauses, Binding Corporate Rules, etc.).
